SINCE 1989, THE COASTAL CONSERVATION LEAGUE HAS BEEN PROTECTING THE SOUTH CAROLINA COASTAL PLAIN-ITS NATURAL LANDSCAPES, ABUNDANT WILDLIFE, CLEAN WATER, AND QUALITY OF LIFE-BY WORKING WITH CITIZENS AND GOVERNMENT ON COMPREHENSIVE SOLUTIONS TO ENVIRONMENTAL CHALLENGES. OUR STAFF WORKS THROUGH FOUR MAIN PROGRAM AREAS: LAND & COMMUNITIES; FOOD & AGRICULTURE; AIR, WATER, & PUBLIC HEALTH; AND ENERGY.

DURING 2015, WE HAD MANY ACCOMPLISHMENTS AND MOVED MANY PROJECTS FORWARD. OUR WORK AT THE LEGISLATURE AND IN CITY AND COUNTY COUNCILS OFTEN TAKES YEARS, AND SOMETIMES DECADES. BELOW ARE SOME HIGHLIGHTS FROM 2015 BY PROGRAM AREA:

ENERGY: THROUGH OUTREACH AND EDUCATION OF ELECTED OFFICIALS, THE CONSERVATION LEAGUE PLAYED AN INTEGRAL ROLE IN SUPPORTING THE PASSAGE OF TWENTY-FOUR (24) OFFICIAL RESOLUTIONS OPPOSING OFFSHORE OIL AND GAS EXPLORATION AND DEVELOPMENT IN THE ATLANTIC. EVERY COASTAL MUNICIPALITY FROM NORTH MYRTLE BEACH TO HILTON HEAD IS INCLUDED IN THIS LIST. IN JULY, THE CONSERVATION LEAGUE CO-HOSTED AN ANTI-OFFSHORE DRILLING EVENT IN MOUNT PLEASANT FEATURING COMMENTS FROM SC SEN. CHIP CAMPSEN AND U.S. REP. MARK SANFORD, TO A CROWD OF MORE THAN 200 PEOPLE. AS A RESULT OF PUBLIC PRESSURE, PRESIDENT OBAMA AGREED TO PROHIBIT OFFSHORE DRILLING ALONG THE ENTIRE EASTERN SEABOARD. GOVERNOR HALEY APPOINTED CONSERVATION LEAGUE STAFF TO AN OFFSHORE ENERGY ADVISORY COMMITTEE THAT WILL BEGIN MEETING NEXT YEAR.

LAND & COMMUNITIES: WORKING WITH MEMBERS OF THE COMMUNITY, WE SUCCESSFULLY THWARTED EFFORTS TO ADD MORE COMMERCIAL DEVELOPMENT TO THE ASHLEY RIVER HISTORIC DISTRICT. FURTHER, DORCHESTER COUNTY PLANNING COMMISSION IS NOW CONSIDERING CHANGES THAT TIGHTEN REGULATIONS FOR FUTURE COMMERCIAL DEVELOPMENT NEAR THE DISTRICT. THROUGH A COLLABORATIVE APPROACH INVOLVING INDUSTRY AND CONSERVATION INTERESTS, THE COASTAL CONSERVATION LEAGUE WORKED ON AN AGREEMENT WITH VOLVO WHICH WILL RESULT IN THE RESTORATION AND PROTECTION OF 2,458 ACRES OF LAND CRITICAL TO PROTECTING ONE OF SOUTH CAROLINA'S NATURAL TREASURES, FOUR HOLE SWAMP. WE WILL CONTINUE TO WORK WITH OUR PARTNERS TO ENCOURAGE AND LEAD THIS TYPE OF LANDSCAPE-SCALE MITIGATION IN THE FUTURE.
